C – First Sergeant (requirements per guidelines)

Minimum Appointment Requirements:

- 1. Minimum Rank: TSgt (promotable to MSgt by closeout date) Maximum Rank: MSgt
- 2. Air Force Specialty Code (AFSC): Any
- 3. Minimum (Secret) security clearance
- 4. Meet physical qualifications IAW DAFMAN 48-123 and AFI 36-2113, para. 5.3.3.
- 5. Meet the requirements of DAFMAN 36-2905, AFI 36-2113, and other regulations as required. Not eligible to receive an Immediate Federal Retirement Annuity (military or civilian).

Applications must contain the following items:

- 1. A letter of intent Follow the "Personal Letter" format found in DAFH 33-337, *The Tongue and Quill*, 16 December 2022, Chp 15
- 2. vMPF Record Review RIP all pages
- 3. Print out of most current fitness tracker report from myFitness
- 4. DD Form 469 (if applicable)
- 5. (Optional) Letter(s) of Recommendation
- 6. Official AF biography IAW DAFH 33-337, (no photo)
- 7. Retraining Memorandum for Record (for TSgts promotable to MSgt only)
 - AFI 36-2113, para. 4.4.3.2. "CCMs ensure Technical Sergeants (TSgts) selected for

and interview are promotable in accordance with AFI 36-2502 and sign the following statement as a condition of promotion under the retraining program; "I acknowledge I am being selected to fill a first sergeant position and I am being promoted under the provisions of AFI 36-2502, Airman Promotion/Demotion Program, paragraph 3.4, before attending the First Sergeant Academy (FSA). I understand I must attend and successfully complete the FSA within one year of appointment as first sergeant and remain and successfully serve in the position a minimum of four years. My failure to complete this requirement will result in a demotion."
